## **DIRECTIONS FOR USE**

\*Apply in the early morning or late afternoon, never in the heat of the day.\*

HOUSEPLANTS: Mix 1-2 Tbsp. Seaweed 8 OR per 1 quart of water. Always shake before using. Apply a fine mist to tops and bottoms of leaves. Moisten only to the point of run-off

\*Can be repeated as often as every two weeks.\*

GARDENS: Apply using houseplant directions -or- Mix 1-2 oz Seaweed 8 OR per 1 gallon of water in a pump up sprayer. Evenly apply fine spray to tops and bottoms of foliage, to the

point of run-off.

\*Repeat weekly during growing season.\*

LAWNS: With pump or hose end sprayer apply 10 oz Seaweed 8 OR per 1000 Sq. Ft. \*Repeat-monthly in season.\*

#### AGRICULTURE: (FOLIAR)

ROW CROPS Mix 1-2 quart(s) Seaweed 8 OR with sufficient water to cover, per acre. Mix in tank with any fertilizer spray mix and follow spray directions for applications. Should be incorporated with any well-balanced fertilizer program.

\*\*\*Highly concentrated DO NOT over apply. \*\*\* To ensure compatibility with foreign spray mixes, a jar compatibility test is recommended before mixing with other products other than water in the tank.
